# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to funded-capital.com, and Moonance LLC and governs data collection and usage.

For the purposes of this Privacy Policy, unless otherwise noted, all references to Moonance LLC include funded-capital.com and Funded Capital. The Funded Capital website is a simulated forex trading site designed to reward retail traders for their talents. By using the Funded Capital website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Funded Capital may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- ID Or Passport Photo For KYC

If you purchase Funded Capital's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Funded Capital collects and uses your personal information to operate and deliver the services you have requested.

Funded Capital may also use your personally identifiable information to inform you of other products or services available from Funded Capital and its affiliates.



## **Sharing Information with Third Parties**

Funded Capital may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Funded Capital, and they are required to maintain the confidentiality of your information.

Funded Capital may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Funded Capital or the site; (b) protect and defend the rights or property of Funded Capital; and/or (c) act under exigent circumstances to protect the personal safety of users of Funded Capital, or the public.

## **Tracking User Behavior**

Funded Capital may keep track of the websites and pages our users visit within Funded Capital, in order to determine what Funded Capital services are the most popular. This data is used to deliver customized content and advertising within Funded Capital to customers whose behavior indicates that they are interested in a particular subject area.

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Funded Capital. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Funded Capital website.

## **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:



Please note that we may not be able to comply with requests to delete your personal information if

it is necessary to:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.
- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Collecting information of minors**

Funded Capital does not knowingly collect personally identifiable information from anyone under the age of 18. You must be 18 years of age or older to sign up at Funded Capital.

### **E-mail Communications**

From time to time, Funded Capital may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication.

If you would like to stop receiving marketing or promotional communications via email from Funded Capital, you may opt out of such communications by responding to any of our emails with “Unsubscribe”.

We may store your data on servers provided by third party hosting vendors with whom we have contracted.
